EXECUTIVE DIRECTOR REPORT:

Electric Supply Bid - Mr. Thorpe indicated that the main purpose of the meeting was to review the results of the electric supply bid. He then asked Mr. Chilton to review the results of the bid with the Board. Mr. Chilton reported that there were 3 prequalified suppliers that submitted all of the necessary paperwork and one decided not to submit a bid. He advised the two bids that were submitted were above the strike price and contract awards cannot be made for any of the bid groups. Mr. Chilton further advised that the high bid prices is overwhelmingly due to the increase in energy prices over the last year, even more notably in the last three months, and the growing cost of the renewable energy component. Mr. Chilton reported that the Energy Consultants will continue to monitor the market very closely, and if something changes, the bid process will be restarted. Chairman Cuccia commented that when the bid results are distributed to the membership, it is important to note that the bid prices are a certain percentage above the tariff prices and that reverting to the utility is the best option currently. Mr. Chilton indicated that he would incorporate that suggestion, as well as Mr. Sacco's suggestion that it is not possible for another vendor to get a better deal because of the market. Chairman Cuccia asked if there was a timeframe in mind for issuing a second bid. Mr. Chilton advised that unless market changes drastically, a second bid could likely be issued late summer or early fall with contract starting in March 2023. Mr. Sacco asked Mr. Chilton to circulate the bid result notice to the Management Committee once it is drafted.
